1. HALF DAY MORNING TRADING SESSION ON WEDNESDAY, 18 FEBRUARY 2015
1.1 Trading on Bursa Malaysia Derivatives will be opened only for morning session on the eve of Chinese New Year on Wednesday, 18 February 2015.

However, where references to 'Business Day' are in relation to non-trading matters, 'Business Day' will be read as one (1) business day ending at the close of business of the Exchange on 18 February 2015.

2. EXCHANGE HOLIDAYS FOR CHINESE NEW YEAR

Bursa Malaysia Derivatives will be closed for business on **Thursday, 19 February 2015** and **Friday, 20 February 2015**. Bursa Malaysia Derivative will resume business on **Monday, 23 February 2015**.
