<u>UNDERLYING INSTRUMENT</u>	<u>FTSE BURSA MALAYSIA MID 70 INDEX (“FBM Mid 70”)</u>

<u>CONTRACT UNIT</u>	<u>FBM Mid 70 multiplied by the Contract Multiplier.</u>

<u>PRICE LIMITS</u>	<ol style="list-style-type: none"> <u>1. <u>FINAL TRADING DAY</u>	<ol style="list-style-type: none"> <u>1. The last Business Day of the contract month.</u> <u>2. Trading in the expiring month Contract ceases at 1715 hours (Malaysia time) on the Final Trading Day.</u>
<u>SETTLEMENT METHOD</u>	<u>Cash Settlement based on the Final Settlement Value.</u>
<u>FINAL SETTLEMENT VALUE</u>	<u>1. The average value, rounded to the nearest index point (values of 0.50 and above being rounded upwards), taken at every 15 seconds or at such intervals as may be determined by the Exchange from time to time from 3.45:30 p.m. to 4.45:15 p.m. plus one value after 5.00pm of the FBM Mid 70 on the Final Trading Day except the 3 highest and 3 lowest values.</u>
